## **ORDER:-**

In the G.O.1<sup>st</sup> read above, Government have launched the Special Recruitment Drive for filling up of the backlog vacancies reserved for Persons with Disabilities in various Government Departments by the end of August, 2002. The time limit for filling up of the backlog vacancies has been extending from time to time.

- In the G.O. 2<sup>nd</sup> read above, Government have extended the time limit for filling up of the backlog vacancies upto 31-03-2018.
- In the reference 3<sup>rd</sup> read above, the Director, Welfare of Disabled & Senior Citizens, Telangana State, Hyderabad has furnished the proposals for extending the time limit for filling up of backlog vacancies for persons with disabilities under special recruitment drive for a further period of one year i.e. upto 31-03-2019.
- Government after careful examination of the matter, hereby 4. extend the time limit for filling up of all the backlog vacancies reserved for persons with disabilities in various Government Departments and Government Bodies under special recruitment drive upto 31-03-2019.
- All the Departments of Secretariat, Heads of Departments and District Collectors are requested to take immediate action to fill up all backlog vacancies by Persons with Disabilities within the extended period.
- The Director, Welfare of Disabled & Senior Citizens Department, 6. Telangana State, Hyderabad is requested to monitor and review the filling up of the backlog vacancies in all the Departments. She is also requested to send a consolidated report on the vacancies filled through the Special Drive.
