### **ORDER:-**

In the reference 1<sup>st</sup> read above, orders were issued enhancing Readers allowance to teachers and lecturers who are visually handicapped at the following rates:

- 1) Secondary Grade Teachers .... Rs.400/- pm  
(Including Craft Instructors)
- 2) School Assistants .... Rs.400/- pm
- 3) Junior Lecturers and above .... Rs.600/- pm

2. In the reference 2<sup>nd</sup> read above, Government issued orders based on the recommendations of the Tenth Pay Revision Commission, 2014 Orders were issued implementing the Revised Pay Scales, 2015 with effect from 1-07-2013 with monetary benefit from 02-06-2014. The Pay Revision Commission has, among others, recommended for increase of Readers allowance.

3. Government hereby accept the recommendation of the Tenth Pay Revision Commission, 2015 and accordingly enhance the rates of Readers allowance as follows:

- 1) Secondary Grade Teacher .... Rs.1,200/- pm  
(Including Craft Instructors)
- 2) School Assistant Teacher .... Rs.1,500/- pm
- 3) Junior Lecturers and above .... Rs.2,000/- pm

4. These orders shall come into force with effect from March 2016.

5. Necessary amendments to the Andhra Pradesh Manual of Special Pays and Allowances shall be issued in due course.
